LIFE AND DISABILITY

Basic Life and AD&D

Liberty Healthcare provides all eligible employees, at no cost, with a basic Life and Accidental Death and Dismemberment benefit through **Lincoln Financial**.

• Employee Benefit: 1 x salary, to a maximum of \$50,000

Important reminder! Please be sure to assign a Beneficiary.

Voluntary Life and AD&D

In addition to your employer-paid life insurance, employees are eligible to purchase additional term life insurance through **Lincoln Financial**.

- *Employee Benefit*: \$20,000 increments to the lesser of 5x salary or \$500,000 (Guaranteed Issue: \$300,000)
- Spouse Benefit: \$10,000 increments to 50% of the employee amount or \$60,000 (Guaranteed Issue: \$60,000)
- Children Benefit: \$10,000 per child

Disability: Short Term

TAX-DEFERRED 401(K) RETIREMENT PLAN

Liberty offers a 401(k) plan managed by **Fidelity Investments**. An employee is eligible to participate in the Company 401(k) Plan immediately upon hire if they are at least 20 years old. Eligible employees will be **automatically enrolled** at a **2.0%** salary deferral unless they contact Fidelity Investments to change or stop the deferral. Employees will have 30 days to opt out or change this deferral amount before it becomes effective.

The current employer match is 35% on the first 4.0% of salary deferred. Employees must work for any Liberty entity for at least one year to begin earning the company match. Employees who are hired through acquisition will retain their original date of hire with the acquired location to determine company match eligibility and for vesting purposes.



Making Changes During the Year

In most cases, your benefit elections remain in effect until March 31. You are not able to make any plan changes unless you experience a life status event such as marriage, divorce, death, etc. All changes must be made within 30 days of the event. You will be required to provide written documentation of the event. Reach out to your HR team for more info.
